Vice Chair Tanner moved to approve October 24, 2019 Regular Meeting Minutes. Seconded by 2nd Vice Chair Rippy. Motion carried 4-0-1. Commissioner Woods was absent.

3. Business:

A. Review of Christmas Light Bus Tour Flyer – ACTION ITEM

Jessica Reid, Customer Service Representative, reviewed the Bus Tour flyer with the Commission.

1. Review Christmas Light Bus Tour Ticket drafts and vote - ACTION ITEM

Jessica Reid, Customer Service Representative reviewed the four Bus Tour ticket drafts with the Commission and asked for feedback.

The Commission discussed the ticket options provided and agreed they preferred the red and green version overall.

Chair Seamons moved to approve the red and green ticket draft as the official Bus Tour ticket layout. Seconded by Vice Chair Tanner. Motion carried 4-0-1. Commissioner Woods was absent.

B. Meet and provide direction on mural project proposed by Kuna High School Alumni

David Durant and Joan (Shannon) Pollikell, Class of 2010 Kuna High School Alumni, gave a general overview of their proposed project and showed a rendering of the "We Remember" American flag mural.

Mr. Durrant explained the mural represented Kuna's rich history and remembered the community's roots. He stated the Class of 2010 wanted to paint the mural on the east side of the Community Hall thus covering over the pioneer mural currently on the building.

Chair Seamons explained that the Alumni may experience some pushback from the Community Hall governing body as they were protective of the murals in and on the building.

Mrs. Pollikell explained the history of the pioneer mural. She said the mural had been a 2010 Kuna High School Art Club project and had never been finished. She wanted to bring the mural full circle by covering over the incomplete work and providing a much more potent mural.

Chair Seamons asked if the Alumni would be willing to put the mural on the west side of the building.

Mr. Durrant expressed his concern that the Girls Scouts mural on the west side would detract from the impact of the mural itself.

Mrs. Pollikell redirected the discussion back to the point of the pioneer mural never having been finished.

Vice Chair Tanner asked the Alumni what guarantees there would be to have the new mural finished and followed through with instead of ending up with a second unfinished mural.

Mr. Durrant explained the KHS 2010 Alumni had discussed the project in length and had a tentative timeline that would maximize the volunteers as to ensure the completion. He

said the projected completion date would be June 20, 2020, he also ensured it would be done even if he would need to complete it himself.

Ms. Reid suggested the Alumni take the Public Art Proposal form, build a presentation around the information then present it to the Community Hall Co-Directors. She reiterated approval would need to come from them for covering up the Pioneer mural, placement of the new mural, etc.

Chair Seamons agreed a presentation would be the best course of action.

Mr. Durrant and Mrs. Pollikell stated they would pursue that avenue, thanked the Commission for their time and exited the meeting.

4. Reports:

A. Kid's Holiday Cookie Decorating

Jessica Reid, Customer Service Representative, notified the Commission the event was still in need of volunteers.

Vice Chair Tanner asked if volunteers would be required to stay for the entire duration of the event or if volunteers could rotate in shifts.

Ms. Reid responded shift rotations would be fine. She also said the optimal number of volunteers during each shift would be three – four (3-4) or no less than two (2).

Vice Chair Tanner replied he could most likely track down some volunteers and would report back to the Commission on the outcome of the search at the following meeting.

B. November 28, 2019 Executive Meeting Canceled

Jessica Reid, Customer Service Representative, reminded the Commission the Executive Meeting would be canceled due to the Thanksgiving holiday.

C. Downtown Art Pads

1. Review of current Art Pad installation schedule

Jessica Reid, Customer Service Specialist, updated the Commission the current four (4) Art Pads would be installed Spring of 2020.

2. Next set of Art Pads schedule

Jessica Reid, Customer Service Representative, reviewed the map of the next seven (7) Art Pad pieces. She explained the remaining Art Pads would coincide with Phase II of the Downtown Revitalization Project beginning in Spring 2020. Ms. Reid also

passed on comment from City Clerk Chris Engels for the Commission to be brainstorming ideas on the remaining Art Pads in order to hit the ground running when the time came.

The Commission reported they understood and would begin brainstorming efforts.
