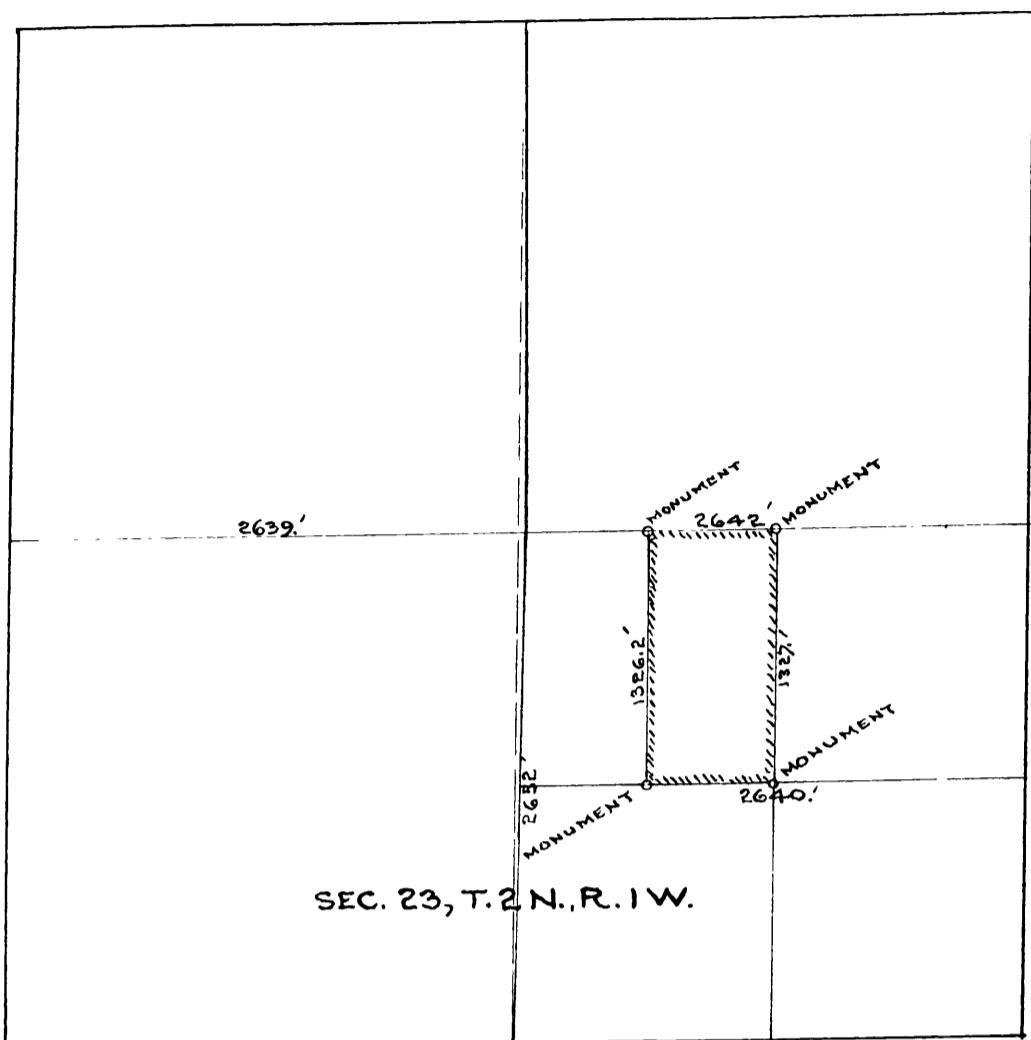


TEED'S ADDITION

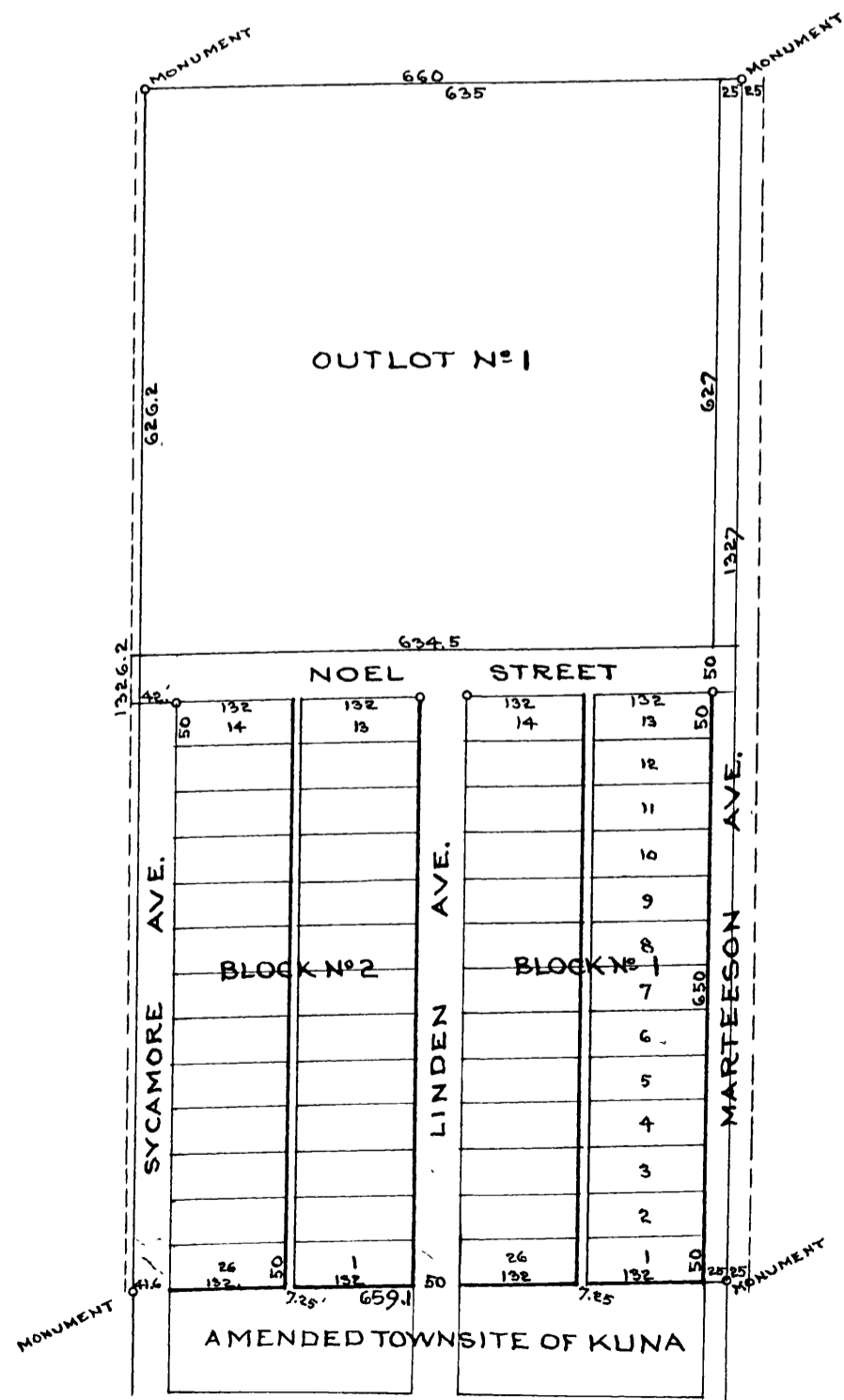
