8. Business Items:

A. April 2018 as Grange Month Proclamation – Mayor Stear (*Timestamp 00:03:51*)

Mayor Stear read the proclamation. He recognized Mr. and Mrs. Johnson as members of the Grange for 52 years.

Don Johnson thanked the Mayor and Council. He shared information on the Grange and an upcoming celebration at 6:30 P.M. on Thursday, April 19, 2018. Everyone was invited. There would also be new paint on the exterior of the building.

B. Financial results of operations through March 31, 2018 – John Marsh, City Treasurer (*Timestamp 00:09:15*)

City Treasurer John Marsh reviewed the funds. The City's cash position was at about \$15.6 million which was good. The General Fund's net income was \$283,037.00. The Water Fund was \$736,272.00. The Sewer Fund was \$811,423.00. The Irrigation Fund was \$298,118.00. All of the funds were in good positions. He stood for questions.

Mayor and Council President Buban-Vonder Haar thanked Mr. Marsh for his presentation.

Mr. Marsh reminded Council if they had a question come up later they could email him and the question would be addressed.

C. Request from Kuna Chamber of Commerce to use the City's movie equipment for Kuna Day's – Chris Engels, City Clerk (Timestamp 00:12:06)

City Clerk Chris Engels presented the Chamber of Commerce's request and stood for questions.

Council President Buban-Vonder Haar asked if they were willing to do the same agreement as the previous year and give the City a booth.

Ms. Engels thought they would.

Council President Buban-Vonder Haar asked if the City needed a booth for anything.

Staff was certain they could come up with something.

Council directed staff to make the agreement with the Chamber of Commerce.

10. Mayor/Council Announcements:

Mayor Stear notified Council that ACHD would be asking for a joint meeting between their Board of Commissioners and the Kuna City Council for some time in June.

Council President Buban-Vonder Haar would be on vacation for a week in June. When the dates were finalized she would send them to Mayor Stear to avoid a conflict with the meeting.

Mayor Stear shared a request to have the early voting trailer at the City Hall Parking Lot that year. He thought it was a good idea. He asked City Clerk Chris Engels if the details had been worked out yet.

Ms. Engels replied they had come by that day. They picked out the spot they wanted to use. She doubled checked with Parks Director Bobby Withrow and Public Works Director Bob Bachman and they could accommodate them. They needed 8 spaces. They would send over promotional items and the City would share it out on the website and social media and change the sign in front of City Hall to get the word out.

Council President Buban-Vonder Haar asked when they wanted to be there and for how many days.

Ms. Engels said just for 1 day but she could not remember the day off the top of her head. She thought it might be May 12, 2018.

Council President Buban-Vonder Haar wanted it to be media blitzed multiple times.

Mayor Stear announced there was new pavement behind City Hall connecting the Greenbelt to the upper parking lot. There would also be a pad at the bottom of the path for performing artists.

Council President Buban-Vonder Haar asked about the dedication set for April 27, 2018.

Ms. Engels shared the details of the dedication of the KUNA! Interactive Art Piece and the formal ribbon cutting for downtown. The event would be at 11:00 am on Friday, April 27, 2018.

Ms. Engels announced they funded in 2 grants the previous week; a \$3,000.00 grant from Idaho Power for Economic Development and a \$500,000.00 TAP grant for Phase II of Downtown Revitalization. There were 2 more pending for \$500,000.00 each. The City also already had \$300,000.00 and would be putting out another one for \$500,000.00. It was all coming together.

Council President Buban-Vonder Haar asked when irrigation would be turned on.

Mayor Stear explained the process to prep for it was already started and that they posted it would be fully operational the first part of May.
